3-5 pm: Students arrive at Xavier University (students are responsible to get here by shuttle or taxi). Please come to the Xavier Student Center at Pine St & Dixon St, New Orleans, LA 70125.

Stay on Washington for approximately four blocks (you will cross South Carrollton at the next light) and enter the campus by turning left onto the bridge at Pine St. Proceed to the corner of Dixon St.

MONDAY, 1/15/07: MLK DAY IN NEW ORLEANS

7-7:45 am: eat at host institution



8:00 -8:15 am: Overview and explanation of day; all students wear Louisiana Winter T-shirts!

8:15 am: Buses Leave

Buses for students staying at Xavier and the Presbyterian church leave for MLK activities. At 9 am we will have a press conference and

rally at the Martin Luther King High School, on the corner of N. Clayborne Ave. and Caffin Ave. We will ask, "how is it possible for us to celebrate King's vision of a 'beloved community' today, and to have the school that bears his name be closed down 1 1/2 years after the hurricane?"

We will then participate in the MLK march. We will march with the NAACP group, but we will also be leafleting the MLK parade ceremony.

Lunch will be a local barbecue restaurant.

After lunch, we will go to the Lafitte housing development to witness, but not participate in, a housing action focusing public housing units. Students who want to participate in the action should contact the organizers of this action. It is important to state clearly that Louisiana Winter students will not be participating in this action, but will be there witnessing it, and learning from it.

Other possible activities: Meet with members from the Southern Christian Leadership Conference, Dr. King's organization.

5 pm: Buses transport students back to Xavier

7:30 pm-9 pm: Reflection on day's events/try to attend Cornel West talk at Xavier

Lodging: 30 plus students housed at Xavier University; others will be housed at a local church.

TUESDAY, 1/16/07: NEW ORLEANS

7-8:15 am: Breakfast at Xavier

8:30-9:30: At Xavier, ACLU teaches the students how to document human rights data. Also, we discuss where in New Orleans to distribute leaflets and document

9:30 am: Buses take students to various New Orleans communities

10 am-4:30 pm: Students pass out Civic Works leaflets and document those people interested in having their story recorded. The host institution will provide bag lunches. Students travel in groups of 4.

Team 1 (20 students) goes to Lower Ninth Ward

Team 2 (20 students) goes to Algiers and lower Algiers

Team 3 (20 Students) goes to Gentilly/Lakeview

* If more students sign up, we will add more teams and go to Holly Grove, St. Bernard Parrish, Northshore (with SCLC/Elwin Warhorse), and uptown and unflooded areas

We also might leaflet at Home Depot, Loews, Wal Mart, the Baptist Seminary (Chef Mentur and Press Blvd), Our Lady of the Sea and Holy Angels Catholic Church

4:30 pm: Buses pick up students and return them to Xavier.
